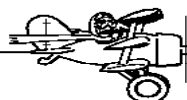

November Program

UAA's Aviation English Program

The University of Alaska Anchorage (UAA) Community and Technical College (CTC) Aviation Technology Division has established an Aviation English Language program. The program is being developed to respond to an international aviation industry safety need to improve language communication in the flight deck.

Announced two years ago, new international rules to address an aviation safety issue require that by March 2008 all international flight crew must meet International Civil

Aviation Organization language proficiency standards for Aviation English - a level that thousands of flight crew do not currently meet.

UAA faculty will provide instruction to foreign in-flight crews at the Merrill Field classrooms and sim lab. Through this program students will experience five to six weeks of intensive language instruction.

Christina Gheen, the UAA Aviation English Coordinator will tell us more about this program that will begin in Spring, 2008 at UAA.

Below is an update on Jenn's condition. Jenn, who works for Smoky Bay Air, was hospitalized for one month following her plane crashed on 19 June. All four passengers aboard survived.

Dear Friends and family,

I am writing you from Sunny Florida. Tiny lizards, warm weather, music playing. I am here with an incredible group of people. Another family of mine that you all would love and enjoy. Michael, my brother is also with me, looking out for me in a way that only a bro could. We are having quite an adventure together. Both on our own paths but walking side by side for support.

I am interning at the International Avatar course in Lake Mary Florida. Michael is my first student, although I am just as often his student, learning from him.

This course teaches us to look at our beliefs. By looking at our beliefs, we learn more about ourselves. By learning more about ourselves, we can identify what we would like to experience and what we would not.

All of you that have been supporting me through this traumatic event have felt first hand the pain and suffering I have been experiencing. I want to thank you from the bottom of my heart for carrying me through the difficult times. I could not have done it alone, nor would I want to.

I am happy to tell you that I am now walking with out crutches or braces on my feet. Just two plain tennis shoes, one much cleaner than the other. When I started this course 9 days ago, I was using two crutches. My wish was to be walking unassisted by the end of the course. Today is the last day and my wish has come true.

I love you all and thank you for your love. Take care until we meet again,

ALERT! COMMENT DEADLINE November 19th: "Advance Information on Private Aircraft Arriving and departing the United States." The Alaska Airmen are concerned with the proposed border crossing rule, which would require pilots to file electronically with customs before entering the US. An advance article on this appeared in our last September/October Transponder. This ruling essentially requires pilots to have internet access prior to takeoff, which is not practical, especially in remote locations such as along the Alaska border with Canada. We also question the need to get permission to leave Alaska or the Lower 48. The Alaska Airmen's Association will submit comments along with other general aviation groups such as AOPA and the California Pilots Association.
